<u>Subject:</u> <u>Add-on voice packs for offering 24 hrs. Unlimited free calls (Local + STD) to any network under broadband combo plans in Hyderabad TD –reg.</u>

- 1. CGMT, AP/ Telangana Telecom Circle may kindly refer to his office proposal vide letter No. TA/CS-I/Tariff BB/2016-17/45 dated 28-01-2017 for waiver of ONT charges, instalments on Type-II BB Modem cost price and for Add-on voice packs in Hyderabad TD.
- 2. The proposal has been examined in this office and the Competent Authority has decided for Add-on voice packs [as introduced vide letter No. 1-1/2016-R&C (CFA) {Circular R&C-CFA No. 16/16-17} dated 18-04-2016 and revised vide letter No. 64-384/2016-17/BB/Tariff dated 02-06-2016] for offering 24 hrs. Unlimited free calls (Local + STD) to any network under DSL/FTTH broadband combo plans with FMC Rs. 700/- & above, in Hyderabad TD of Telangana Circle on regular basis.

Details are as follows:

- a) Add-on Voice pack of Rs. 48/- per month for making 24 hrs. Unlimited calls to any network within circle.
- b) Add-on Voice pack of Rs. 98/- per month for making 24 hrs. Unlimited (local + STD) calls to any network in India.
- c) The above add-on voice packs shall be available only to the Broadband users for "retail use" having Broadband combo plan with plan FMC Rs. 700/- & above.
- d) The "retail use" is defined as follows:
 - i. Outgoing calls should be less than 300 unique numbers in a month.
- e) If the customer availing add-on voice packs as above, has not fulfilled the retail use condition as per para (d) above, add-on voice pack shall not be applicable and the customer will be charged as per existing broadband plan tariff. In this regard, applicability of 'add-on' pack will be checked on monthly basis
- f) The customer should be educated properly for the retail use condition as above and an undertaking to this effect shall be taken from the customers availing add-on voice packs.
- g) The above add-on voice packs shall be available only in Hyderabad TD of Telangana circle.
- h) The circles should ensure that above add-on voice packs are offered to Broadband users for retail use in those cities/locations/colonies of the Hyderabad TD, where there is similar offering from other operators.
- The Circle shall ensure to comply with all regulatory mechanism and also <u>update circle website</u>.
- 4. These instructions shall be <u>effective with immediate effect on regular basis in Hyderabad TD of Telangana Telecom Circle only.</u>
- 5. All other terms and conditions shall remain same as per earlier circulars.
- 6. This circular is issued based on the approval of Competent Authority in Broadband cell file No. 64-409/2016-17/BB/Tariff.
