Hence charges for registration, modem, installation, security deposit under above plan and any other eligible broadband plan are 'NIL' only upto 31 net connections per rural DSLAM as per the BSNL-USOF agreement dated 20-01-2009. These charges beyond 31 connections per DSLAM shall be chargeable at existing prescribed rate.</u>
