Subject: Introduction of standalone limited Broadband Plans exclusively for PCOs on Promotional basis for a period of 90 days for all Circles-reg.

It has been decided by the Competent Authority to introduce standalone limited Broadband Plans exclusively for the PCOs on promotional basis for a period of 90 days w.e.f. 01.11.2010 for all Circles. The tariff of the new Broadband Plans for PCOs are as follows:
