Subject: Authorization to CGMs for launching of <u>promotional offer of giving 100 free call for a period of six months in lieu of free</u> <u>modem</u> to the prospective postpaid Broadband customers who opt for the BB plan <u>where free modem is available as a</u> <u>part of package</u> – reg.

The Competent Authority has decided to authorize all the CGMs to approve the following promotional scheme in their circles upto the period of <u>next three months</u> from the date of issue of this order.

<u>"The prospective postpaid BB customers, who opt for the BB plan where free modem is available as a part of package,</u> may be offered 100 free calls per month for a period of six months in lieu of the free modem irrespective of the type of modem."

- 2. The 100 free calls as above shall be over and above the normal free calls already available under the chosen BB plan and *shall* have to be utilized during respective month.
- 3. The promotional scheme may be launched on *month to month basis i.e.* initially *for one month* and *extendable by one month each time upto three months* depending upon the status of availability of CPEs and local requirements.
- 4. The above scheme shall be subject to the feasibility in the CDR & other billing systems.
- 5. All other relevant terms and conditions as per the earlier circulars shall continue to be applicable.
