

Subject: Introduction of Wi-Fi plan ‘BSNL Wi-Fi Free Airport’ for retail customer at Airports under Wi-Fi services in association with HSSPs (Hot Spot Service Providers) -reg.

1. It has been decided by the Competent Authority **“to introduce new Wi-Fi Plan “ BSNL Wi-Fi Free Airport” for the Wi-Fi Hot Spot services (in association with HSSPs) to retail customers at Airports as follows:**

Plan Name	Price (inclusive of Service tax)	Wi-Fi Duration
BSNL Wi-Fi Free Airport	NIL	First 30 Minutes free Wi-Fi usage once in a month for same mobile number

2. **The above “BSNL WiFi Free Airport” plan shall be offered only at Airports Wi-Fi Hotspots.**
3. **During free Wi-Fi usage, speed to any user shall be restricted to 256 Kbps.**
4. **The circles shall ensure to comply with all regulatory mechanism.**
5. **All other terms and conditions shall remain same as per earlier circulars.**
6. The above instructions **shall be effective with immediate effect in all the circles at Airports only.**
