## Circular R&C-CFA No. 01/18-19

## Subject: Introduction of new 'Broadband only' DSL plan (without voice facility) 'BBO ULD 249 CS279' in MP Circlereg.

- CGMT, MP Circle may kindly refer to his office proposal vide letter no. CGMT/CFA-Mktg/03-02/ECT Minutes/12-13/CH-I/42 dated 16-03-2018 seeking approval for 'Broadband only' DSL plans (without voice facility) 'BBO ULD 249 CS279' in reaming SSAs of MP Circle.
- 2. The proposal has been examined by the tariff committee and the competent authority has decided to introduce new 'Broadband only' plan (without voice facility) 'BBO ULD 249 CS279' on promotional basis for a period of 90 days, only at those places of MP Circle where BSNL is not able to provide voice facility. 

- 3. It should be also ensured by the Circle that above 'Broadband only' plans are offered at only those places of MP Circle where BSNL is not able to provide voice facility.
- 4. Since all the DSL BB plans are available on FTTH with same tariff, above plan shall also be available on FTTH with same tariff.

- 5. The Circle shall ensure to comply with all regulatory mechanism *including online reporting to TRAI and also update the Circle website.*
- 6. These instructions shall be effective with immediate effect on promotional basis for 90 days in MP Circle as above.
- 7. All other terms and conditions shall remain same as per earlier circulars.
