  - *iii.* Free PRBT (Personalized Ringback Tone), on all three SIMs.
  - *iv.* Free online TV on one of the mobile SIM out of the three.
  - v. One month free subscription of online Education for any one Subject to the student's upto class-XII, on one of the mobile SIM out of the three.
