Subject: <u>Introduction of new broadband plans "BBG Combo ULD 850 CS12"</u>, "BB Home Combo ULD 900 CS13", and "BBG Combo ULD 1000 CS14" only in Chennai TD – reg.

CGM Chennai TD may kindly refer to his D.O No. DGM (S&M)-CFA/BB Combo plans/2012-2013 dated 12.07.2012 seeking approval for exclusion of **off-net calls** from free calls under some of the combo broadband plans in Chennai TD.

2. The proposal has been examined in this office and <u>Competent Authority has decided to launch new broadband</u> <u>plans "BBG Combo ULD 850 CS12", "BB Home Combo ULD 900 CS13", and "BBG Combo ULD 1000 CS14" only in Chennai TD with the tariff as follows:-</u>

- 3. The rates indicated are exclusive of Service Tax, which will be charged extra as per prevailing tariff.
- 4. Since above plans are mirrored plans of the existing "BBG Combo ULD 850", "BB Home Combo ULD 900" and "BBG Combo ULD 1000" plans (with only change as "free calls to be offered as On-net calls only" and Off-net calls are to be charged), hence with the launch of above plans, the existing combo plans "BB Home Combo ULD 900", "BBG Combo ULD 850" and "BBG Combo ULD 1000" shall not be offered to the new customers in Chennai TD.

- 5. <u>Existing customers falling under "BBG Combo ULD 850", "BB Home Combo ULD 900" and "BBG Combo ULD 1000" plans, who have completed more than six months in the plan, shall be migrated to new respective plan after giving an advance intimation of one month.</u>
- 6. The circle shall ensure to comply with all regulatory mechanism.
- 7. The monthly charges for modems will be the same as circulated vide this office letter **No. 64-03/08-Broadband** dated **18.02.2010** and their sale price will be the same as circulated vide this office letter **No. 64-03/08-Broadband** dated **15.07.2010**.
- 8. All other relevant terms and conditions, as mentioned in earlier circulars, shall remain unchanged.
- 9. These instructions shall be effective w.e.f. 21-08-2012 in Chennai TD only.
- 10. This circular is issued based on the approval of Competent Authority in Broadband cell file No. 64-133/BB/Tariff/10-11/May/01. - 11. The plans shall be reviewed after 90 days.
