Subject: Launch of promotional schemes under Broadband services for the prospective broadband customers registering their broadband connection upto 31-03-2012– reg.

It has been decided by the competent authority <u>to launch following promotional schemes under Broadband</u> <u>services for the prospective broadband customers registering their broadband connection upto 31-03-2012</u>:-

- a. Waiver of Installation Charges as follows:
 - i. An existing BSNL landline customer who takes a new standalone / Combo postpaid broadband plan, Broadband installation charges may be waived off.
 - ii. A customer who takes a new postpaid broadband plan with new landline connection (i.e. fresh Combo plan), Broadband installation charges and landline installation charges may be waived off.
 - iii. A customer who takes a new **Prepaid** Broadband connection, Broadband installation charges may be waived off.
- b. <u>Security Deposit for Broadband</u> (as applicable for the opted plan) may be taken in three equal monthly installments starting from first bill.
- c. <u>Modem Security Deposit</u>: may be taken in three equal monthly installments starting from first bill in case Modem is taken on rental basis from BSNL.
- d. Free VAS on Broadband as follows:
 - i. Free Games on Demand (M/s Indiagames) Casual Package worth Rs.100/- per month for one month.
 - ii. Free Music and Video on Demand (M/s Hungama) Package worth Rs.149/- per month for one month.

Note: - <u>No revenue share shall be payable to the franchisees (M/s Indiagames & M/s Hungama) under this scheme</u> for a period of one month being free services provided to the customers.

e. One GSM Mobile Prepaid SIM (MRP Rs. 20/-) may be offered free to all the new broadband customers.

Note:- <u>No commission shall be payable to the franchisees/DSAs etc. for providing the free GSM Mobile prepaid SIM as</u> <u>above.</u>

- 2. All other relevant terms and conditions as per the earlier circulars shall continue to be applicable.
- 3. This circular is issued based on the approval of Competent Authority in Broadband Cell File No. 64-133/BB/Tariff/11-12/Pt.2. - 4. These concessions shall be applicable with immediate effect for the prospective broadband customers registering their broadband connection upto 31-03-2012 only.
