Kindly refer to this office letter no. 1-1/2012-R&C [CFA] (Circular No. 58/12-13) dated 18-02-2013 vide which FMC of 'BB Home ULD 499' was revised from Rs. 499/- to 525/-. Kind reference is also invited to this office letter of even no. (Circular No. 59/12-13) dated 19-02-2013 vide which 'BBG 700' plan was withdrawn for prospective customers.

2. Now, it has been decided by the Competent Authority **to re-open "BB Home ULD 499" plan for existing Enterprise Customers only (till the validity of current agreements) and "BBG 700" plan for only e-governance projects of govt. with the details as follows:-**
