# Sub: <u>Tariff for Volume based Recharge Vouchers for Prepaid Broadband Services on DSL</u> access-reg.

This has reference to this office Circular No. R&C CFA No. 09/09-10 dated 19.10.2009 regarding tariff for Prepaid Broadband services on DSL access. It has been decided by competent authority to introduce **volume based plan vouchers of Prepaid Broadband services as follows**:-

After expiry of the additional grace period of 45 days (\*\*GP-2), the account of the customer shall be deleted from the system
