 - (i) Above plans shall be available only for the new Broadband customers. However, any existing BSNL landline (i.e. not having Broadband) customers can migrate under above plans.
 - (ii) Above plans shall not be available on FTTH.
 - (iii) After six months, existing customers under above plans shall be migrated to regular Broadband plans. Customer's consent in this regard shall be taken at the time of CAF filling.
 - To curb the tendency of existing Broadband customers to disconnect existing BB connection & take new BB (iv) connection through this low value BB plans route, same landline indicator shall not be allotted to such customers. The same shall be ensured by the ITPC/Circles.
