Sub: Introduction of Promotional schemes under VVoBB services in the Circles under North & West Zone - reg.

The approval of Competent Authority is hereby conveyed for launch of following VVoBB plans in the Circles under North & West zone on promotional basis for a period of 90 days.

I. VVoBB Sulabh Plan bundled with landline without (i) outgoing call facility, (ii) internet browsing facility (i.e. Broadband without Broadband Account) with tariff as follows:-

- c. The charges of multiple VVoBB connections shall be billed in a single group bill to make billing and collection of payment from single customer.

- d. <u>Fixed Monthly charges for Landline & Broadband and Call Charges for landline & usage charges for Broadband shall be as per the plan selected by the customer.</u>
- e. b. Service tax as applicable will be charged extra.
