Subject: <u>Provision of free incoming VVoBB service to all ADSL BB customers in Gujarat Telecom Circle on promotional</u> basis for a period of 90 days - reg.

It has been decided by the Competent Authority <u>to provide free incoming VVoBB service (outgoing VVoBB</u> facility to be barred) without providing PVC and fixed static IP to all the ADSL BB customers in Gujarat Telecom <u>Circle</u> on promotional basis for a period of 90 days.

- 2. The data usage charges for data transfer will be levied as per existing plan availed.
- 3. VVoBB Number shall only be given to those customers who download the required software and softphone.
- 4. VVoBB incoming facility should only be made operational with softphone and no incoming or outgoing facility should be made available with hardphone.
- 5. The above promotional scheme shall be effective from 27-12-2011 on promotional basis for a period of 90 days in Gujarat Telecom Circle only.
- All other relevant terms and conditions as per the earlier letter No; [1-1/2009-R&C (CFA)Pt. dated 15.07.2011 (Circular No. 14/11-12), NWP-BB No. 64-44/09-Broadband/SIS dated 25.08.2011 and 1-1/2009-R&C [CFA]Pt. dated 01.11.2011 (Circular No. 34/11-12)] shall continue to be applicable.
- 7. This circular is issued based on the approval of Competent Authority in NWP-BB file No. 64-187/2011-BB/Tariff.
