Subject: Introduction of 'Security Deposit Charges' under WiFi plans for Bulk user customer in association with HSSP (Hot Spot Service Provider) in all the Circles-reg.

1. Kindly refer to this office order vide letter No.1-1/2015-R&C-CFA [Circular R&C-CFA No. 31/15-16] dated 08-06-2015 wherein WiFi plans for Bulk user customer in association with HSSP (Hot Spot Service Provider) were introduced and also letter No. 1-1/2015-R&C (CFA) [Circular R&C-CFA No. 115/15-16] dated 30-11-2015 wherein 10 Mbps Bulk user WiFi Hotspot plan has been revised.

Now, it has been decided by the Competent Authority **"to collect security deposit charges equal to two months plan charges under WiFi plans (annual/quarterly) for Bulk user customer [introduced vide BSNL CO letter No. 1-1/2015-R&C (CFA) (Circular R&C-CFA No. 31/15-16) dated 08-06-2015] in all the Circles"**.
3. ***The circles shall ensure to comply with all regulatory mechanism.***
4. ***All other terms and conditions shall remain same as per earlier circulars.***
5. The above instructions **shall be effective w.e.f. 11-05-2016 in all the Circles.**
