 - a) **Revision in existing prepaid WiFi plans for WiFi Hot Spot services in association with Hot Spot Service Providers (HSSP) on PAN India basis on promotional basis for 90 days as follows:-**

6. The Circles shall ensure to comply with all regulatory mechanism.
7. These instructions shall **be effective w.e.f. 27-05-2016 in all the circles on promotional basis for 90 days.**
