**Circular R&C-CFA No. 181/15-16**

**Subject: Revision of validity under some of the volume based prepaid WiFi plans for the WiFi Hotspot Services in association with Hot Spot Service Provider (HSSP)-reg**

1. Kindly refer to this office letter vide letter No.1-1/2015-R&C-CFA [Circular R&C-CFA No. 151/15-16] dated 27-01-2016 wherein prepaid WiFi plans has been revised from duration based to volume based for the WiFi Hot Spot Services in association with Hot Spot Service Provider (HSSP).
2. Now, it has been decided by ***the Competent Authority to revise validity of some of the existing volume based prepaid WiFi plans (introduced vide R&C-CFA circular No. 151/15-16 dated 27-01-2016) for the WiFi Hot Spot services (in association with Hot Spot service provider) to retail customers on PAN India basis (including major Ghats of Varanasi) on promotional basis for 90 days as follows:-***

3. ***The circles shall ensure that there should not be any impact on existing broadband/3G revenue due to above WiFi plans.***
4. ***All other terms and conditions shall remain same as per earlier circulars.***
5. The Circles shall ensure to comply with all regulatory mechanism.
6. These instructions shall **be effective w.e.f. 11-03-2016 in all the Circles.**
7. This circular is issued based on the approval of Competent Authority in Broadband cell file No. 64-392/2015-16/WiFi HotSpot/Tariff.
