Subject: Review of tariffs of Internet Leased Line (ILL) services of BSNL-regarding

The tariffs and other terms and conditions of Internet Leased Line (ILL) services of BSNL (for 1:1, 1:2 and 1:4) were issued vide this office letter no. 111-3/2004-comml. dated 01.3.2004, 30.9.2004, 10.02.2005 and 30.3.2011 and further revised vide letter no. 111-3/2004-comml. dated 20.9.2004, 30.11.2005, 04.05.2006, 27.11.2006, 08.01.2010, and 15.01.2008.

2 The competent authority has reviewed the present tariff of Internet Leased Line (ILL) services of BSNL (for 1:1, 1:2 and 1:4) and has decided to revise the same as under:

2.1 Tariff for Internet Leased Line Ports:

3. Other terms and conditions:

- (i) There would not be any difference in tariff for ISP and Non-ISP categories.
- (ii) The discount, **including discount to educational Institutions and loyalty discount**, already provided to the existing customers will not be applicable on the new tariff. However, customers will migrate to the revised tariff after the expiry of the commitment period. The circles will have to revise the discount on the new tariff to the existing customers.
- (iii) The charges for intermediate bandwidths will be on proportionate basis.
- (iv) Local lead charges shall be applicable in MTNL area on back to back payment basis.
- (v) All other terms and conditions will remain same as envisaged in earlier circulars mentioned above.
- (vi) The above mentioned tariff is applicable **w.e.f. 01.04.2012**.


