Sub: Modification in Tariff plan of SIP Trunking Services from NGN System (above 50 Channels)-Reg.

Ref: No: 1-1/2020-R&C [CFA] (circular R&C CFA No. 11/20-21) dated 12.06.2020.

- 1. Please refer to above mentioned circular vide which New Tariff plan of SIP Trunk service has been issued.
- 2. CGM, NCNGN may please refer to his office letter No. RCNGN/BG/55/SIP Trunk/2017-18/82 dated 14.07.2020.
- 3. In this regard now the competent authority on the recommendations of CFA- tariff committee has approved following modifications:

a. DIDs per Concurrent Channel:

- i. Maximum DIDs (including pilot number) per concurrent channel shall be 10.
- ii. 2 DIDs per concurrent channel shall be provided free and DIDs beyond 2 and up to 10 per concurrent channel shall be provided on chargeable basis at Rs 10/- per DID per month.

b. Monthly Free calls (Local + STD)

Monthly free calls (Local+STD) shall be provided in the form of worth fixed amount in INR, in place of currently provided in Minutes. Based on this modified table for SIP Trunk tariff is as follows:
