Subject: - Infrastructure Charges for Provisioning of Last Mile on RF Media through Customer Owned Radio Modem – regarding

This office has received a proposal from Maharashtra Telecom Circle on the above-mentioned subject. The proposal has been examined in this office and it has been decided by the competent authority that Last Mile on RF Media may be provided through Customer Owned Radio Modem for BSNL's cutomers only (and not for customers of other Licence telecom service provider) on the following tariff and terms & conditions:

2. Tariff:

(a) One time charges for facilitating installation of RF equipment & start of service from BSNL premises: Rs. 5000/- (Five Thousand) Only. These charges are one-time charges and will be charged by BSNL to facilitate installation of RF equipment & start of service from BSNL premises.

(b) Security Deposit : Since the customer is owning the equipment and installing at our premises, BSNL may take one year infrastructure charges as security deposit in advance.

(c) Annual charges for use of BSNL Infrastructure : Rs. 10000/- per annum.

3. Other terms and conditions :

All regulatory / licensing and technical guidelines should be followed, while (i) allowing such radio modems to be installed in BSNL premises.

No expenditure shall be incurred by BSNL in providing Last Mile on RF (ii) Media through Customer Owned Radio Modem.

The equipment shall be low power wireless equipment (e.g. Wi-Fi max. (iii) transmitter output power of 1 watt-4 watt ERP with spectrum spread of 10 MHz or higher.) In case the power consumption is higher, additional charges will be payable.

Installation & de-installation of antenna/Radio/Modem will be the (iv) responsibility of customers.

Commissioning and maintenance will be the responsibility of customer. (v)

BSNL will not be responsible for any losses. (vi)

It will be the responsibility of the customer to Install and maintain the (vii) Haiter One Allin Radio Modem.

(viii) <u>Minimum Period of Hire</u>: Minimum period of hire should be one year for BSNL's services.

(ix) In regard of above-mentioned Para, an under taking must be taken from the customer.

(x) **Charges for use of BSNL Infrastructure**: Customer should agree to pay all the charges, as decided by the BSNL, in advance. These charges include

a. One time charges for facilitate installation of RF equipment & start of service from BSNL premises

b. Charges for infrastructure may be annual.

c. All Applicable taxes will be extra on above-mentioned tariff.
