- b) Terms & conditions for providing above Broadband plans:
 - (i) The plans shall be available for the new Broadband customers.
 - (ii) However, any existing BSNL landline (i.e. not having Broadband) customers can migrate under 'BBG Combo ULD 300 GB' & 'BBG Combo ULD 600GB' Plan only.
 - (iii) The plans shall not be available on FTTH.
 - (iv) After six months, existing customers under above plans shall be migrated to regular Broadband plans. Customer's consent in this regard shall be taken at the time of CAF filling.
 - (v) To curb the tendency of existing Broadband customers to disconnect existing BB connection & take new BB connection through this low value BB plans route, same landline indicator shall not be allotted to such customers. The same shall be ensured by the ITPC/Circles.

- 2. All other terms and condition shall remain same as per earlier circulars.
- The Circle shall ensure to comply with all regulatory requirements including online reporting to TRAI and also update the Circle website.
- 4. The above instructions shall be <u>effective with immediate effect on promotional basis for a period of 90 days</u> in all the Circles (except A&N Circle).
