




**Circular R&C-CFA No. 143/17-18**

**Subject: Introduction of FTTH Broadband plans 'Fibro Combo ULD 895 CS99', 'Fibro Combo ULD 1095 CS100', 'Fibro Combo ULD 1295 CS101', 'Fibro Combo ULD 1495 CS102', 'Fibro Combo ULD 1795 CS103', 'Fibro Combo ULD 2095 CS104' and 'Fibro Combo ULD 3295 CS105' on regular basis in Faridabad SSA of Haryana Circle.**

- CGMT Haryana Circle may kindly refer to his office proposal vide letter no.
