
Subject: Introduction of new FTTH Broadband plan 'Fibro Combo ULD 1999 CS280' in Telangana Telecom Circle – reg.

1. CGMT Telangana Circle may kindly refer to his office proposal vide letter No. TA/CS-I/Tariff BB/2016-17/61 dated 23-02-2018 seeking approval for new FTTH Broadband plan 'Fibro Combo ULD 1999', introduction of unlimited calls under FTTH plan with FMC more than Rs. 600/- and extension of Add-on voice packs to the plan of FMC 470 and above.
2. The proposal has been examined by the tariff committee and the competent authority has decided **to introduce new FTTH Broadband plan 'Fibro Combo ULD 1999 CS280' on promotional basis for a period of 90 days in Telangana Telecom Circle.**

4. ***It should be ensured by the Circle that above plan is offered in only those locations/colonies of Telangana Circle where there is a matching competition from other operator.***
5. ***The Circle shall ensure to comply with all regulatory requirements including online reporting to TRAI and also update the Circle website.***
6. All other terms and conditions shall remain same as per the earlier circulars.
7. These instructions shall ***be effective with immediate effect on promotional basis for a period of 90 days in Telangana Circle only.***


