Subject: Reformulation of FTTH Broadband tariffs – reg.

The Competent Authority has decided to reformulate the FTTH Broadband tariffs as follows:-

1. To withdraw existing Fibro Broadband plans for new FTTH customers:

It has been decided by the Competent Authority that *following FTTH (Fibro) Broadband shall not be offered to the prospective FTTH customers henceforth for subscriptions:*

Existing customers under the above plans shall continue. However efforts may be made by the field units to migrate these customers in other plans (*any existing ADSL plan or new Fibro plan*).

It has been decided by the competent authority to extend the above promotional scheme for further period of 180 days.


4. Circles shall ensure to comply with all regulatory mechanism.
5. All other relevant terms and conditions w.r.t. FTTH Broadband services, as mentioned in earlier circulars, shall remain unchanged.
6. These instructions shall be effective w.e.f. 01-09-2013 in all the circles.
