Sub: - Revision in size of Centrex Group w.r.t. waiver of Centrex facility charges to the voice connections on FTTH in a particular complex of one or more building for all the Circles.

1. Gujarat Circle vide letter No. Mktg.-CFA/Tariff Proposal/2019-20/39 dated: 03-09-2019 proposal to waive off Centrex facility charges for more than 10 voice connections over Bharat Fiber in case of residential societies, complex of one or more buildings etc. in all SSAs of Gujarat Telecom Circle.
2. Kindly refer BSNL CO BP-Enterprise unit circular No. 111-05/2012-BP-Ent dated 30-04-2012 & R&C CFA circular R&C-CFA No. 75/12-13 dated 18-03-2013 regarding Centrex facility through FTTH services.
3. Now, the Competent Authority has decided to revise the Centrex facility charges for all the Circles w.r.t. the voice connections on FTTH in a particular complex of one or more building as follows:

5. ***The Circle shall ensure to comply with all regulatory mechanism including online reporting to TRAI and also update the Circle website. Further, Circle shall ensure to maintain the TRAI guideline w.r.t. number of plans.***
6. ***These instructions shall be effective with immediate effect in all the Circles.***
