Ref: (1) Letter No. 3-1/2010-R&C [CFA] dated 16.3.2011 reg. Promotional Bundling Scheme "UITC JEEVAN SATHI Bundling Scheme": *Circular no 62/10-11*(2) Letter No. 3-1/2010-R&C [CFA] dated 16.3.2011 reg. Launch of Smart ITC Card on promotional basis: *Circular no 63/10-11*

Kindly refer to the above mentioned circulars. In this regard, some field units have raised some queries. In this regard, I am directed by the competent authority to clarify the following -

## 1. With reference to letter at Sr.no 1 regarding UITC Jeevan Saathi Promotional Bundling Scheme:

a. For States other than J&K

Bundling Scheme 1

MRP = Rs 110 + Rs 55= Rs 165 Talk value = Rs 100(main card) + Rs 70(promotional card ISD Barred) **Bundling Scheme 2** MRP = Rs 300 + Rs 55= Rs 355 Talk value = Rs 281(main card) + Rs 90(promotional card ISD Barred)

b. For J&K

Bundling Scheme 1 MRP = Rs 110 + Rs 55= Rs 165 Talk value = Rs 110(main card) + Rs 75(promotional card ISD Barred) Bundling Scheme 2 MRP = Rs 300 + Rs 55= Rs 355 Talk value = Rs 310(main card) + Rs 95(promotional card ISD Barred)

- **c.** All existing features are available in above promotional cards of MRP Rs 55 except ISD calling facility.
- **d.** To avail this Promotional Bundling Scheme, BSNL Franchisee / EPIN franchisee / DSA must purchase this card before 31.3.2011. However, these cards can be sold by them after 31<sup>st</sup> March 2011 also.
- e. Customers can use these cards after 31<sup>st</sup> March 2011 also but within validity period as printed on the card.
- **f.** Increased talk value is not applicable on purchase of individual card of MRP Rs. 55 without this offer.
- g. Customers are permitted to purchase Rs 110 and Rs 300 UITC cards without this bundling offer also.

## 2. With reference to letter at Sr.no 2 regarding Smart ITC

- a) Smart ITC is for new customers of FLPP General (Fixed line prepaid over Post-paid)
- b) The existing (old profile) accounts of FLPP General are not to be migrated to new profile.
- c) Grace period of 10 days is applicable on Retail Account Card of MRP Rs. 110/-.
- **d)** To avail this promotional scheme, BSNL Franchisee / EPIN franchisee / DSA must purchase this card before 31.3.2011. However, these cards can be sold by them after 31<sup>st</sup> March 2011 also.
- e) Customers can use these cards after 31<sup>st</sup> March 2011 also but within validity period as printed on the card.
- f) This card is accessible from BSNL Landline/Mobile.
