Circular R&C-CFA No. 14/12-13

Subject: Rationalization of existing rates for ISD calls made from Landline network in Rs/ Minutes-reg.

Kind reference is invited to this office letter No. 3-1/2010-R&C(CFA) dated 21.01.2011 and dated 28.02.2011 & 23.05.2012 [Circular No. 51/10-11, 58-10/11 & 07/12-13 respectively] through which the ISD tariff (MCU based) for calls made through **BSNL landline network** was fixed/modified.

2) The matter has been further reviewed in this office with reference to ILD carrier charges and Competent Authority has now decided to introduce MOU based ISD Tariff with 60 seconds pulse for calls made to destinations falling in the Countries mentioned in **Annexure** by the subscribers of following landline and WLL (fixed) phones Plans (along with corresponding advanced rental plan).

- i. One India Plan.
- ii. Standard Package Rural.
- iii. General Rural/Urban
- iv. Gramin-75
- v. Sulabh
- vi. UL-350/450/500/600.
- vii. TV-250
- viii. AO-225/325/375/475
- ix. Plan 600/1200/2160

3) The ISD tariffs at uniform Pulse Rate of 60 Sec is to be implemented with rates as indicated in enclosed Annexure.

4) In view of MOU based ISD tariff, the MCU accrued from ISD calls (@ 60 sec pulse) are to be excluded from counting of free MCU being given under such plans.

5) The above tariff shall be applicable w.e.f **13.08.2012**.

6) The Charge band related information shall be issued separately by NWO-CFA cell.

7) All regulatory requirements may kindly be complied with while implementing the above tariff.

8) This may be brought to the notice of all concerned and necessary steps may be taken for its proper implementation.

9) The circular is issued based on the approval of Competent Authority in NWO-CFA Cell File No. 25-10/2011NWO-CFA/IN.
