- 1. The Competent Authority on recommendation of Tariff Committee-CFA has approved revision of tariff for "Virtual" Landline connections under plan 'ASEEM' on PAN India basis. The details are as follows:
 - Call diversion from "Virtual" landline number to any one BSNL number of subscriber's choice @ Rs.99/p.a.
 - (ii) Call diversion from "Virtual" landline number to any one other network's number of subscriber's choice @ Rs.199/p.a.
 - (iii) DNP Customers for three months or more can take "Virtual" landline connection under plan
 - (iv) On shifting of residence in TNF area, existing landline customers shall be allowed to opt "ASEEM" plan.
 - (v) Voluntary closure customers are allowed to opt for "ASEEM" plan.
 - (vi) For existing customers tariff may be revised as per TRAI guidelines.
 - (vii) All other terms & conditions shall remain same.
- 2. The Circle should ensure to comply with all regulatory requirements.
- 3. The above instructions shall be *effective from <u>01.09.2017</u>*.
