**Subject: Rationalization of advance payment of Fixed Monthly Charges (FMC) Plans viz; Annual, Two years, Three years payment option in respect of Broadband and applicability of the same to landline plans on PAN INDIA basis-reg.**

Proposal for rationalization of advance payment of fixed monthly charges (FMC) plans viz; Annual payment option presently available under Landline & Broadband service both and two years/three years payment option presently available under Broadband service was under consideration in this office.

2 The matter has been examined in this office and it has been decided by the Competent Authority to rationalize the **advance payment of Fixed Monthly Charges (FMC) Plans viz; Annual, Two years, Three years payment option for Landline, Broadband services as below:**

- 3 The existing customers, already under annual, two years and three years option, shall not be charged the revised tariff till the expiry of their current annual/two years/three year's subscription.
- 4 **The revised tariff shall be applicable form 01-04-2013.**
- 5 **The Circles should ensure to comply with all regulatory requirements.**
