Subject: Extension of entry level unlimited Broadband plan 'Experience Unlimited BB 249' (with migration to 499 plan after six months) on promotional basis till 30th June 2017 in all the circles (except J&K and A&N telecom circles) - reg.

- 1. Kindly refer to this office letter No. 1-1/2016-R&C (CFA) {Circular R&C-CFA No. 117/16-17} dated 02-09-2016 vide which Broadband plan 'Experience Unlimited BB 249' (with migration to 499 plan after six months) was introduced in all the circles.
- Now, the Competent Authority has decided <u>for the entry level Broadband plan 'Experience Unlimited BB 249'</u> (with migration to 499 plan after six months) [as introduced vide letter No. 1-1/2016-R&C (CFA) {Circular R&C-CFA No. 117/16-17} dated 02-09-2016] on promotional basis for a further period upto 30th June 2017 in all the circles except J&K and Andaman & Nicobar Telecom Circles.

Details of the plan are as follows:

- 3. All other terms & conditions for availing Broadband plan 'Experience Unlimited BB 249' shall remain same as per earlier circulars and clarifications issued from time to time by NWP-BB Unit of BSNL CO.
 - *i.* The plan shall be available only for the new Broadband customers.
 - ii. The plan shall also be available on FTTH with the same tariff.
 - *iii.* Installation charges shall be waived off during promotional period.
 - *iv.* After six months, plan shall be converted to 'BBG Combo ULD 499' plan. Customer's consent in this regard shall be taken at the time of CAF filling.
 - v. To curb the tendency of existing Broadband customers to disconnect existing BB connection & take new BB connection through this low value BB plan route, same landline indicator shall not be allotted to such customers. The same shall be ensured by the ITPC/Circles.
 - vi. All other charges shall be as per existing.

- 4. The Circle should ensure to comply with all regulatory mechanism.
- 5. These instructions shall be <u>effective w.e.f. 01-04-2017 on promotional basis for a period upto 30th June-2017 in <u>all the circles (except J&K and A&N circles)</u>.</u>
- 6. This circular is issued based on the approval of Competent Authority in Broadband cell file No. 64-402/2016-17/BB/Tariff.
