## Subject: - Introduction of 'Friends & Family' Add On Plan for Landline customers - regarding.

1. The Competent Authority on recommendation of Tariff-Committee-CFA has approved <u>'Friends & Family'</u> <u>scheme</u> for Landline customers on PAN India basis.

The details are as follows:

- (i) Under this scheme a fixed landline customers can choose one additional number of his family/ friends of any network and may be allowed unlimited calling to that no. by paying Rs.21/- per month.
- (ii) Under this scheme a fixed landline customers can choose two additional numbers of his family/ friends of any network and may be allowed unlimited calling to that no. by paying Rs.39/- per month.
- (iii) Under this scheme a fixed landline can choose three additional numbers of his family/ friends of any network and may be allowed unlimited calling to that no. by paying Rs.49/- per month.
- 2. The tariff order will be applicable from date of issue of circular on PAN India basis.
- 3. The Circle should ensure to comply with all regulatory requirements.
