- 2) Hyderabad Telecom District is a multi exchange area and in case of shifting & retaining of the same vanity no. at a later stage to a different exchange area, approval of BSNLCO is required afresh, after getting technical feasibility from ITPC.
- 3) Normal charges like Security Deposit, Installation charges shall be applicable.
- 4) In order to rule out any possible misuse wherein auction numbers are further auctioned by successful bidders, specific details of those customers will be captures for which bid is made, even if payment liability continues to be with the BSNL customer.
