**Circular R&C-CFA No.167/16-17**

**Subject: Re-launch of 'Broadband Only' DSL plans (without voice facility) 'BBO ULD 799', 'BBO ULD 949', 'BBO ULD 1199' & 'BBO ULD 1449' on regular basis in all the circles -reg.**

1. CGMT, all Telecom Circles/Metro Telephone Districts, may kindly refer BSNL CO letter vide No. 1-1/2016-R&C (CFA) {Circular R&C-CFA No. 91/16-17} dated 22-07-2016 wherein 'Broadband Only' DSL plans (without voice facility) 'BBO ULD 799', 'BBO ULD 949', 'BBO ULD 1199' & 'BBO ULD 1449' were introduced in all the circles.
2. Now, it has been decided by the Competent Authority *"to re-launch 'Broadband Only' DSL plans (without voice facility) 'BBO ULD 799', 'BBO ULD 949', 'BBO ULD 1199' & 'BBO ULD 1449' [as introduced vide letter No. 1-1/2016-R&C (CFA) {Circular R&C-CFA No. 91/16-17} dated 22-07-2016] on regular basis in all the Circles."*
3. *The circle shall ensure that above 'Broadband only' plans are offered at only those places where BSNL is not able to provide voice facility.*
4. *Since all the DSL plans are available on FTTH with same tariff, the above plans shall also be available on FTTH with same tariff.*
5. The circle shall ensure to comply with all regulatory mechanism **and also update the circle website.**
6. All other terms and conditions shall remain unchanged.
7. These instructions shall **be effective w.e.f. 01-12-2016 in all the Circles on regular basis.**
8. This circular is issued based on the approval of Competent Authority in Broadband cell file No. 64-402/2016-17/BB/Tariff.
