 - b) To upgrade the bandwidth under Broadband plans 'BBG Combo ULD 699 CS85', 'BBG Combo ULD 875 CS86' and 'BBG Combo ULD 1025 CS88' in Chennai TD w.e.f. 01-07-2017 for all the existing/new BB customers as follows:-
