1. Competent authority on recommendation of Tariff Committee-CFA has approved revision of Tariff for Sulabh Plans as follows:

**Sulabh Plan(Exchange capacity < 30000 Line):-**

FMC Exchange Capacity <30000 line (in Rs.)	90	110
Free Call	Nil	Nil
Call Charges	Rs.1.20/MCU for all Network	Rs.1.20/MCU for all Network
All other charges/terms and conditions shall remain unchanged.		

2. The above charges will be applicable **on PAN India Basis**.
3. The revised tariff will be applicable **from 01.05.2015**.
4. Guidelines of TRAI shall be followed by ITPC Circle. FMC shall be revised for customers only after completion of six months in the plan.
5. **The Circle shall comply with all regulatory requirements.**
