Subject: Revision of condition of plan FMC limit from Rs. 700/- to Rs.600/- for availing add-on voice packs for offering 24 hrs. Unlimited free calls (Local + STD) to any network under broadband combo plans in selected SSAs of few Circles -reg.

- 1. It has been decided by the competent authority to revise the plan FMC condition from 'Rs.700/- & above' to 'Rs.600/- & above' under DSL/FTTH Combo Broadband plans for availing add-on voice packs for making 24 hrs. Unlimited free calls (Local + STD) to any network in selected SSAs of few circles. Details are as follows:
 - a) Add-on Voice pack of Rs. 48/- per month for making 24 hrs. unlimited calls to any network within circle.
 - b) Add-on Voice pack of Rs. 98/- per month for making 24 hrs. unlimited (local + STD) calls to any network in India.
 - c) The above add-on voice packs shall be available only to the Broadband users for "retail use" having Broadband combo plan with <u>plan FMC Rs. 600/- & above</u>.
 - d) The "retail use" is defined as follows:
 - i. Outgoing calls should be less than 300 unique numbers in a month.
 - e) If the customer availing add-on voice packs as above, has not fulfilled the retail use condition as per para (d) above, add-on voice pack shall not be applicable and the customer will be charged as per existing broadband plan tariff. In this regard, applicability of 'add-on' pack will be checked on monthly basis.
 - f) The customer should be educated properly for the retail use condition as above and an undertaking to this effect shall be taken from the customers availing add-on voice packs.
 - g) The above add-on voice packs are presently available only in following SSAs/Circles on regular basis:
 - i. Jaipur SSA of Rajasthan Circle.
 - ii. Faridabad & Gurgaon SSA of Haryana Circle.
 - iii. Bhopal, Indore, Jabalpur & Gwalior SSAs of MP Circle.
 - iv. Hyderabad TD of AP/Telangana Circle.
 - v. Ahmedabad SSA of Gujarat Circle.
 - vi. Karnataka Circle.
 - vii. Ghaziabad & Noida SSAs of UP (West) Circle.
- 2. The Circles shall ensure to comply with all regulatory mechanism and also update circle website.
- 3. These instructions shall be <u>effective w.e.f. 10-03-2017 in above SSAs of concerned circles & in Karnataka Circle only.</u>
- 4. All other terms and conditions shall remain same as per earlier circulars.
