Subject: Introduction of promotional scheme to waiver of 100% installation charges for new Landline, Broadband, LL+BB, FTTH Broadband connections and for those customers of Karnataka Telecom Circle, whose landline/broadband connections were earlier disconnected due to any reason till 30th Nov-2015 and they want to come back to BSNL- reg.

1. CGMT Karnataka Circle may kindly refer to his office proposal letter no. MKTG-CFA/28/Corp. Tariff/LL-BB-PCO/15-16 dated 22-12-2015, seeking approval for waiver of installation charges for new LL, BB, LL+BB and FTTH Broadband connections in Karnataka telecom circle.
2. The proposal has been examined in this office and following has been decided by the Competent Authority.
 - a) ***To introduce promotional schemes to waiver of 100% Installation charges for new landline, Broadband, LL+BB and FTTH broadband connections for a period upto 31-03-2016 in Karnataka Telecom circle only.***
 - b) ***To introduce a promotional scheme to waiver of 100% installation charges for landline/broadband for a period upto 31-03-2016 to those customers of Karnataka Circle only, whose landline/broadband connections were earlier disconnected due to any reason till 30th Nov-2015 and they want to come back to BSNL.***
 - c) ***The circle shall ensure that there are no outstanding dues against such customers.***
3. ***The Circle will ensure to comply with all regulatory mechanism***
4. All other terms and conditions shall remain unchanged.
5. These instructions shall **be effective with immediate effect for a period upto 31-03-2016 on promotional basis in Karnataka circle only.**
