## Circular T&C-CM No. 48/11-12

**Sub: Special VPNoWiMAX Tariff for NMEICT Projects under Wireless Broadband Services (WiMAX)-reg.**

Kindly refer to this office order of even No. dated 14.06.2011 vide which tariff of VPNoWiMAX was issued. Now it has been decided by the Competent Authority to allow VPN over WiMAX facility to NMEICT Projects where wire-line based ADSL2+ connectivity is not feasible and offer the special VPNoBB tariff applicable to NMEICT under wire-line Broadband service to VPNoWiMAX under WiMAX services. The special VPNoBB tariff is as per letter No.64-53/09-Broadband dated 23.11.2009 issued by Network Planning-Broadband and Billing and Accounting as per letter No.72-03/09-BP (Pt.) dated 21.04.2010 issued by Broadband Cell and as revised/modified from time to time.


2. The above VPNoWiMAX tariff will be implemented with **immediate effect**.
3. This may be brought to the notice of all concerned for taking necessary action in this regard. Proper advertisement as deemed fit may be made to generate adequate response.
4. This circular is issued based on the approval of the Competent Authority in NWP-WiMAX cell File No. BSNL CO/NWP-WiMAX/2009-10/Tariff, for WiMAX services.
