### **Sub: Introduction of Data STV bundled with Mobile TV Pack from M/s. Digivive Services Pvt. Ltd.**

BSNL (VAS cell) has entered into an agreement with M/s. Digivive Services Pvt. Ltd. for providing BSNL Mobile TV to Mobile customers of BSNL on revenue share Basis. The Competent Authority has approved the tariff for Data STV for bundling of mobile TV channels pack with M/s. Digivive Services Pvt. Ltd. as under:-

- A) Data STV: MRP Rs. 211/- (Incl. of S. Tax) [BSNL-Rs. 136/-, M/s. Digivive –Rs.75/-\*]  
B) Freebies offered:

- The freebies offered will be consumed within 30 days from the date of activation.
- The above tariff will be implemented w.e.f. **16.12.2013**.
- \*Expenses on account of VAS retailing through C-Top up will be applicable on Rs. 75/- (Incl. of S. Tax) i.e. the VAS component only (not on BSNL component) and will be governed as per letter No. 200-29/2012-VAS dated 6-08-2013.
- This may be brought to the notice of all concerned for taking necessary action in this regard. Press note and proper advertisement as deemed fit may be made to generate adequate response. Circles may also send SMS conveying the above scheme to the customers.
- Circles have to update their website and report the same to TRAI as per tariff reporting requirement of TRAI.


