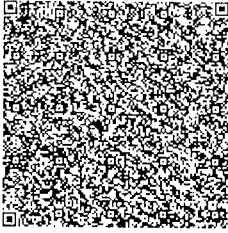

PALAYA, NEAR FUN WORLD, BANGALORE – 560 006 acting through, the authorized signatory (hereinafter called **3G STORE SYSTEMS INDIA PRIVATE LIMITED** which expression shall, unless repugnant to the context, include its successors in business, administrators, liquidators and assigns or legal representatives) of the SECOND PARTY.

WHEREAS :

1. BSNL is engaged in the business of providing telecom services throughout the country except the metro districts of Delhi and Mumbai.
2. 3G STORE SYSTEMS INDIA PRIVATE LIMITED is engaged in the business of manufacturing GSM Mobile Devices, in the manufacture, import, distribution and

sale of these Mobile Devices and various mobile communication products and accessories.

3. BSNL and 3G STORE SYSTEMS INDIA PRIVATE LIMITED are desirous to establish an arrangement under which the parties shall work on terms set out herein for the benefit of both the parties in developing a bundled devices solution, which combines Mobile Devices and mobile connection. This arrangement is expected to enhance value to the Mobile customers of BSNL and GSM Mobile Devices customers of 3G STORE SYSTEMS INDIA PRIVATE LIMITED. This arrangement is also expected to increase overall demand of Mobile connections as well as GSM mobile device.

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In consideration of the due observance & performance of all the terms and conditions mentioned in this agreement the **Part I to III** attached hereto & forming part of this agreement, BSNL and the **3G STORE SYSTEMS INDIA PRIVATE LIMITED**. agree to sign agreement on non-exclusive basis for bundling of BSNL Mobile connection and GSM Mobile Devices manufactured or marketed by **3G STORE SYSTEMS INDIA PRIVATE LIMITED** for the benefit of Mobile customers of BSNL and **3G STORE SYSTEMS INDIA PRIVATE LIMITED** as per conditions contained in various parts & Annexure attached hereto..
2. **3G STORE SYSTEMS INDIA PRIVATE LIMITED** and BSNL hereby agrees and unequivocally undertakes to fully comply with all terms and conditions stipulated in agreement along with **Part I to III** attached hereto without any deviation or reservations of any kind, unless mutually agreed between the parties at any given

time. The details of the scheme may be changed from time to time on mutually agreed basis, based on market condition.

3. BSNL reserves the right to provide the GSM Mobile Devices on its own or to enter into Agreement with other GSM Mobile Device vendors/manufacturers for bundling of GSM Mobile Devices of any other vendor/manufacture with Mobile connection of BSNL in future without any restriction of number of Mobile Device vendors/ manufactures.
4. The laws of land as promulgated/modified/amended or replaced from time to time shall govern this Agreement.
5. The **3G STORE SYSTEMS INDIA PRIVATE LIMITED** shall indemnify BSNL in respect of any consequences of whatsoever nature arising on account of copy right/intellectual property rights violation in respect of Software/Hardware of GSM Mobile Devices, whichever and whatever is supplied by **3G STORE SYSTEMS INDIA PRIVATE LIMITED** to the customer.
6. This Agreement shall not be amended or modified or altered or changed in any way except in writing and duly executed by the authorized representative of each party.
7. The Agreement is a confidential document. **3G STORE SYSTEMS INDIA PRIVATE LIMITED** and BSNL shall not divulge any part of this Agreement either through oral or written communication or through any other mode to any third party.

TERMS & CONDITIONS

PART-I

COMMERCIAL CONDITIONS

1. SCOPE OF THE WORK :

- 1.1 **3G STORE SYSTEMS INDIA PRIVATE LIMITED** shall
- Provide for sale of their GSM Mobile devices cards etc through their Distribution Network who will sell GSM Mobile devices after bundling with BSNL Mobile Services (2G, 3G SIM Cards etc).
 - **3G STORE SYSTEMS INDIA PRIVATE LIMITED** distributors will provide their GSM Mobile devices to BSNL's Distribution Channel who will sale these devices after bundling with BSNL mobile connection.
- 1.2 A monthly schedule of targets for **3G STORE SYSTEMS INDIA PRIVATE LIMITED**, for BSNL bundle sales, will be drafted circle-wise.
- 1.3 The demand estimation of GSM Mobile Devices bundled will be done centrally at the corporate office in consultation with **3G STORE SYSTEMS INDIA PRIVATE LIMITED** and respective nodal officer as assigned by the GM Sales and Marketing of the circle customer mobility business unit
- 1.4 The demand estimation will be done at least three months in advance in order to provide sufficient time to **3G STORE SYSTEMS INDIA PRIVATE LIMITED** to issue Mobile Devices in appropriate quantities. The demand will be estimated in mutual agreement of BSNL and **3G STORE SYSTEMS INDIA PRIVATE LIMITED** while keeping in mind potential sales for each circle and the market share of **3G STORE SYSTEMS INDIA PRIVATE LIMITED**.

- 1.5 Based on estimated demand, the number of SIM cards will be earmarked to M/s **3G STORE SYSTEMS INDIA PRIVATE LIMITED** at the corporate office and will be sent to the circle. Circle can not issue these SIM cards to any other vendor or any SSA for unbundled sale.
- 1.6 **3G STORE SYSTEMS INDIA PRIVATE LIMITED** will designate a key BSNL account manager & Circle level Managers to run the process from their side with Circle level Managers of BSNL i.e. GM(Sales / Mktg).
- 1.6 **3G STORE SYSTEMS INDIA PRIVATE LIMITED** will submit circle-wise and model-wise sale details on monthly basis to the Demand Manager of Corporate Office.
- 1.7 **3G STORE SYSTEMS INDIA PRIVATE LIMITED** distribution channel and BSNL's distribution channel will display prominently bundled data card/solution with BSNL mobile connection at its distribution network.
- 1.8 **3G STORE SYSTEMS INDIA PRIVATE LIMITED** will be responsible for presale service installation of required software or any accessory / helpdesk support/ after sales service / warranty / guarantee etc of GSM data card inter-alia payment of sales Tax etc thereon on its own cost, to be bundled with BSNL mobile service / SIM, for the customers who will buy bundled GSM Mobile devices. For this purpose BSNL will neither be responsible nor will pay any charges to **3G STORE SYSTEMS INDIA PRIVATE LIMITED**
- 1.9 **3G STORE SYSTEMS INDIA PRIVATE LIMITED** shall also be responsible for obtaining the copyrights and complying with the Intellectual Property Rights of the hardware and software or any other item. **3G STORE SYSTEMS INDIA PRIVATE LIMITED** will also comply with all laws, rules, regulations, for bundling of GSM Mobile Devices including any permission for bundling of products etc. **3G STORE SYSTEMS INDIA PRIVATE LIMITED** shall indemnify BSNL in respect of any consequences of

whatsoever nature arising on account of copyright violation with respect to GSM Mobile Devices.

- 1.10 It is specifically agreed by the **3G STORE SYSTEMS INDIA PRIVATE LIMITED** that it shall, at no point of time, use the BSNL name, logo, space and services under this agreement for sale of GSM Mobile Devices which are not for sale only to BSNL customers, unless agreed between the parties in writing save and except that BSNL undertakes to allow **3G STORE SYSTEMS INDIA PRIVATE LIMITED** to sale GSM devices without bundling.
- 1.11 **3G STORE SYSTEMS INDIA PRIVATE LIMITED** shall provide warranty as per the **3G STORE SYSTEMS INDIA PRIVATE LIMITED** existing norms of the GSM Mobile Devices sold under this scheme of bundled GSM Mobile Devices at its own cost. The devices faults shall be attended by **3G STORE SYSTEMS INDIA PRIVATE LIMITED** customer care/fault repair centre. **3G STORE SYSTEMS INDIA PRIVATE LIMITED** shall mention its help desk details in its advertisement / promotion in English & in local vernacular language in an easily readable / comprehensible format.
- 1.12 **3G STORE SYSTEMS INDIA PRIVATE LIMITED** shall provide post warranty support to the GSM data card sold under this scheme of bundled GSM Mobile Devices.

2. MARKETING OF BUNDLED GSM MOBILE DEVICES :

- 2.1 Based on the projected volumes, **3G STORE SYSTEMS INDIA PRIVATE LIMITED** will identify Mobile Devices (Data card Model + Color) for BSNL bundled in consultation with the corporate office within seven days.

- 2.2 **3G STORE SYSTEMS INDIA PRIVATE LIMITED** will undertake marketing, advertising, promotion, etc. of bundled GSM Mobile Devices on mutually agreed basis.
- 2.3 **3G STORE SYSTEMS INDIA PRIVATE LIMITED** will pack BSNL SIM in such a manner that BSNL brand /logo on the SIM is displayed prominently. The packaging design for the bundled GSM Mobile Devices and SIM shall be mutually agreed by both parties. The packing design shall be approved by marketing cell of Corporate Office.
- 2.4 **3G STORE SYSTEMS INDIA PRIVATE LIMITED** will mention "Pack contains free BSNL SIM" on all bundles in order to make customer aware of bundling offer on the pack and that can not be sold without the SIM.
- 2.5 The responsibility of the **3G STORE SYSTEMS INDIA PRIVATE LIMITED** and M/s BSNL with respect to marketing / promotion of the scheme will be broadly as given below:
- 2.5.1 **BSNL** will mainly take care of promotion of the bundled scheme through mass media wherever feasible.
- 2.5.2 **3G STORE SYSTEMS INDIA PRIVATE LIMITED** will mainly be responsible for promotion of the bundled scheme through *BTL (Below the line) marketing* i.e. merchandizing, mailers, pamphlets, leaflets, coupons, mailers, brochures, website based advertising, broadcast advertising, telemarketing etc and *outdoor* promotion activities i.e. billboards, posters, signage etc.
- 2.6 Neither of the party will go public through press, media or through any other medium, about the scheme without mutual consent.

- 2.7 Both the parties as per requirement will mutually agree for the budget of marketing/promotion of the scheme based on the merit of the scheme.
- 2.8 The creative and other promotional material for any kind of advertisement shall be approved by both parties before release in public/media.

3. **DURATION OF AGREEMENT :**

This agreement shall be valid for a period of **ONE** year from the date of signing the Agreement unless revoked earlier for whatever reasons. If at any stage during the tenure of this agreement, it comes to the notice of BSNL, directly or through some other complaint, that **3G STORE SYSTEMS INDIA PRIVATE LIMITED** had misrepresented the facts or submitted any false information or hidden any information, which could have affected the signing of this agreement with the 3G STORE SYSTEMS INDIA PRIVATE LIMITED, this agreement shall stand terminated immediately under intimation to the 3G STORE SYSTEMS INDIA PRIVATE LIMITED.

4. **EXTENSION OF AGREEMENT :**

BSNL may extend, if deemed expedient, the period of agreement by ONE year at one time, upon request of **3G STORE SYSTEMS INDIA PRIVATE LIMITED**, if made at least one month before expiry of currency of the agreement, on mutually agreed terms. The decision of BSNL shall be final in regard to the grant of extension.

5. **MODIFICATIONS IN THE TERMS AND CONDITIONS OF AGREEMENT :**

The terms and conditions of the Agreement are subject to modification by mutual agreement based upon the request of either party. In case of no

6. RESTRICTIONS ON 'TRANSFER OF AGREEMENT' :

3G STORE SYSTEMS INDIA PRIVATE LIMITED shall not assign or transfer its right in any manner whatsoever under this agreement to a third party except as agreed in the agreement or enter into any agreement for sub-contracting and /or partnership relating to any subject matter of the agreement to any third party either in whole or in any part i.e. no sub-contracting/ partnership/ third party interest shall be created.

7. SUSPENSION, REVOCATION OR TERMINATION OF AGREEMENT :

7.1 BSNL reserves the right to suspend the operation of this Agreement, at any time, due to change in its own license conditions or upon directions from the competent Government Authorities. In such a situation, BSNL shall not be responsible for any damage or loss caused or arisen out of aforesaid action. Further, the suspension of the agreement will not be a cause or ground for extension of the period of the agreement and suspension period will be taken as period spent. During this period, no charges for use of the facility of **3G STORE SYSTEMS INDIA PRIVATE LIMITED** shall be payable by BSNL.

7.2 BSNL may, without prejudice to any other remedy available for the breach of any conditions of agreement, by a written notice of ONE month issued to **3G STORE SYSTEMS INDIA PRIVATE LIMITED** at its registered office, terminate this agreement under any of the following circumstances:

- **3G STORE SYSTEMS INDIA PRIVATE LIMITED** failing to perform any obligation(s) under the Agreement;
- **3G STORE SYSTEMS INDIA PRIVATE LIMITED** failing to rectify, within the time prescribed, any defect as may be pointed out by BSNL.
- **3G STORE SYSTEMS INDIA PRIVATE LIMITED** going into liquidation or ordered to be wound up by competent authority.

7.3 EITHER PARTY may terminate the Agreement, by giving notice of at least ONE month in advance. The effective date of surrender of agreement will be ONE month counted from the date of receipt of such notice by the other party or the authority that signed the agreement on behalf of other party.

7.4 If the **3G STORE SYSTEMS INDIA PRIVATE LIMITED** is wound up or goes into liquidation, it shall immediately (and not more than a week) inform about occurrence of such event to BSNL in writing. In that case, the written notice period can be modified by BSNL as deemed fit under the circumstances. BSNL may either decide to issue a termination notice or to continue the Agreement by suitably modifying the conditions, as it feels fit under the circumstances.

7.5 It shall be the responsibility of **3G STORE SYSTEMS INDIA PRIVATE LIMITED** to maintain the agreed Quality of Service / equipment, even during the period when the notice for surrender/ termination of agreement is pending.

7.6 Breach of non-fulfillment of Agreement conditions may come to the notice of BSNL through complaints or as a result of the regular monitoring. Wherever considered appropriate BSNL may conduct an inquiry either

suo-moto or on complaint to determine whether there has been any breach in compliance of the terms and conditions of the agreement by **3G STORE SYSTEMS INDIA PRIVATE LIMITED** or not? **3G STORE SYSTEMS INDIA PRIVATE LIMITED** shall extend all reasonable facilities and shall endeavor to remove the hindrance of every type upon such inquiry.

8. ACTIONS PURSUANT TO TERMINATION OF AGREEMENT :

a. Notwithstanding any other rights and remedies provided elsewhere in the agreement, upon termination of this agreement:

- Neither Party shall represent the Other Party in any of its dealings.
- Neither Party shall intentionally or otherwise commit any act(s) as would keep a third party to believe that the Other Party is still the former Party's service provider, as the case may be.
- Each party shall stop using the other Party's name, trademark, etc., in any audio or visual form.
- The expiration or termination of the Agreement for any reason whatsoever shall not effect any obligation of either Party having accrued under the Agreement prior to the expiration or termination of the Agreement and such expiration or termination shall be without prejudice to any liabilities of either Party to the other Party existing at the date of expiration or termination of the Agreement.
- **3G STORE SYSTEMS INDIA PRIVATE LIMITED** shall return all the unsold SIM cards, if any, & clear BSNL's due within 30 days of termination, failing which M/s **3G STORE SYSTEMS INDIA PRIVATE LIMITED** shall be liable to pay 12% interest P.A. thereon.

2. DISPUTE SETTLEMENT :

9.1 In the event of any question, dispute or difference arising under this Agreement or in connection there-with (except as to the matters, the

decision to which is specifically provided under this agreement), the same shall be referred to the sole arbitration of the CMD, BSNL, New Delhi or in case his designation is changed or his office is abolished, then in such cases to the sole arbitration of the officer for the time being entrusted (whether in addition to his own duties or otherwise) with the functions of the CMD, BSNL or by whatever designation such an officer may be called (hereinafter referred to as the said officer), and if the CMD, BSNL or the said officer is unable or unwilling to act as such, then to the sole arbitration of some other person appointed by the CMD, BSNL or the said officer. The agreement to appoint an arbitrator will be in accordance with the Arbitration and Conciliation Act 1995.

9.2 There will be no objection to any such appointment on the ground that the arbitrator is a BSNL Servant or that he has to deal with the matter to which the agreement relates or that in the course of his duties as a BSNL servant he has expressed his views on all or any of the matters in dispute. The award of the arbitrator shall be final and binding on both the parties to the agreement. In the event of such an arbitrator to whom the matter is originally referred, being transferred or vacating his office or being unable to act for any reason whatsoever, the CMD, BSNL or the said officer shall appoint another person to act as an arbitrator in accordance with terms of the agreement and the person so appointed shall be entitled to proceed from the stage at which it was left out by his predecessors.

9.3 The arbitrator may from time to time with the consent of both the parties enlarge the time frame for making and publishing the award. Subject to the aforesaid, Arbitration and Conciliation Act, 1996 and the rules made there

under, any modification thereof for the time being in force shall be deemed to apply to the arbitration proceeding under this clause.

9.4 The venue of the arbitration proceeding shall be the office of the CMD, BSNL, New Delhi or such other places as the arbitrator may decide.

10. FORCE – MAJEURE :

If at any time, during the continuance of this Agreement, the performance in whole or in part, by either party, of any obligation under this is prevented or delayed, by reason of war, or hostility, acts of the public enemy, civic commotion, sabotage, Act of State or direction from Statutory Authority, explosion, epidemic, quarantine restriction, strikes and lockouts (as are not limited to the establishments and facilities of **3G STORE SYSTEMS INDIA PRIVATE LIMITED**, fire, floods, natural calamities or any act of God (hereinafter referred to as **event**), provided notice of happenings of any such event is given by the affected party to the other, within 21 Calendar days from the date of occurrence thereof, neither party shall, by reason of such event, be entitled to terminate the agreement, nor shall either party have any such claims for damages against the other, in respect of such non-performance or delay in performance. Provided Service under the agreement shall be resumed as soon as practicable, after such event comes to an end or ceases to exist. The decision of BSNL as to whether the service may be so resumed (and the time frame within which the service may be resumed) or not, shall be final and conclusive. However, the Force-majeure events noted above will not in any way cause extension in the period of the agreement.

11. RIGHT TO INSPECT :

11.1 Wherever considered appropriate BSNL may conduct any inquiry either suo-moto on complaint to determine whether there has been any breach in compliance of terms & conditions of the agreement by **3G STORE SYSTEMS INDIA PRIVATE LIMITED** or not? In case of such inquiry, **3G STORE SYSTEMS INDIA PRIVATE LIMITED** shall extend all reasonable facilities without any hindrance.

12. CONFIDENTIALITY OF INFORMATION :

12.1 Subject to conditions contained in this Agreement, **3G STORE SYSTEMS INDIA PRIVATE LIMITED** shall take all necessary steps to safeguard the privacy and confidentiality of any Information about BSNL and its subscribers from whom it has acquired such information by virtue of the Service provided and shall use its best endeavors to secure that:

No person acting on behalf of **3G STORE SYSTEMS INDIA PRIVATE LIMITED** himself divulges or uses any such information except as may be necessary in the course of marketing of bundled GSM Mobile Devices; and

- No person seeks such information other than is necessary for the purpose of selling bundled GSM Mobile Devices.

Provided, the above Para i.e. 12.1 shall not apply where BSNL has consented in writing to such information being divulged or used, and such information is divulged or used in accordance with the terms of that consent; or the information is already open to the public.
