Kindly, refer to the E-mail cited under reference-1 on subject matter vide which Kolkata telecom District informed that the sale of Postpaid CDMA connections has been stopped due to non availability of Module in Sancharsoft for CDMA Postpaid Provisioning. As per mail Kolkata Telecom District informed that he has sent the proposal to ITPC Hyderabad but till date no action has been taken by ITPC Team.


Vide letter under reference-2, Addl. GM (NWO-II) CM, Rajasthan Telecom Circle has already requested to ITPC Hyderabad for implementation of provisioning of CDMA postpaid connection through Sancharsoft.

Vide letter no 69-07/2008-CDMA/Vol.II dated 11-01-2013, this office has also requested to ITPC for early implementation of sancharsoft for provisioning of CDMA connection (Letter enclosed).

From above mentioned reference letter/Email, it appears that provisioning of CDMA postpaid connections have not been implemented so far through sancharsoft.

In view of above, it is requested to integrate the module for provisioning of CDMA Postpaid connections, so that sale of postpaid connection can be done through sancharsoft.

As per telephonic report received from area's , No postpaid connections in Calcutta Telephones is being sold due to nonavailability of Module in Sancharsoft for Postpaid Provisioning.

We are expecting provisioning totally automatic in line with Prepaid CDMA Sancharsoft , but as a stopgap arrangement one temporary modal was devised and approved from CGM Sir and the same was forwarded to Sales Unit . As per mail Sales unit had already sent the proposal to ITPC HYD on May 7 itself. But till no positive outcome is being seen.

New Customer provisioning is almost stopped in the Circle , and so new probable Customers are also getting deprived from (20% Discount on Data Card), as well as 20 % Discount on FMC and Usages for Govt Employee as it limited period offer from BSNL CO.

Hence , it is requested to kindly intervene in the matter at the earliest so that new connection provisioning in Circle can be resumed.


Sub.:- Regarding Sancharsoft & new CAF implementation in CDMA.

received from GM (WLL&WiMax), UP (E) Telecom circle.

Kindly, refer the letter cited under reference on the subject matter, where in UP(E) circle have mentioned that Sancharsoft has not been implemented/Partially implemented in CDMA. Some other circles have also informed that new CAF verification process has not been implemented in CDMA.

On inquiry from WINs Vadodara and Bangalore it appears that sancharsoft have been partially implemented for CDMA product (Only for paired RUIM) and some work are still pending from B&CCS side. Some work related to new CAF verification process is also pending from B&CCS/ITPC side. Email copy of detail of pending work received from WIN Vadodara is enclosed.

In view of above fact, all are requested to resolve the above issues on **top most priority by 15.01.2013.**
