Circular T&C-CM No. 76/11-12

Sub: Clarification on applicability of postpaid Add-on plan under GSM service to CDMA based postpaid service-reg.

Kindly refer to this office order of even No. dated 05.02.2010 vide which CDMA postpaid tariff was rationalized and order No. 26-18/2009-R&C(Pt.) dated 29.12.2010 vide which inter-alia, tariff for Add-on plan for GSM service was issued. As per existing orders, one Add-on plan in the form of rent free second lower plan is allowed to BSNL's loyal customers having connections under high end GSM postpaid plans with FMC of Rs.325 & above and have completed six months in BSNL with the following terms and conditions .

a) Security deposit	NIL
b) Activation Charges	Rs.100
c) Fixed Monthly Charges	NIL
d) Calls between main and add-on number	Free
e) Free call/SMSs	NIL
f) Reduced rate calls (Local/STD) and any other freebies	Not allowed
g) All other charges	As per second lower plan


Note:- The disconnection of the main number will automatically disconnect the Add-on number. An under taking from the subscriber of main connection may be obtained for payment of all dues of the Add-on number.

2. Based on queries raised by field units regarding the tariff applicability of the GSM Add-on connection to CDMA customer, the following clarifications are issued.

i) Since, all GSM based postpaid tariff plans are applicable to CDMA based postpaid services for both full mobility and Fixed/Limited mobility services in circles where CDMA billing has been migrated to B&CCS, the Add-on plan as applicable under GSM services will also be applicable to CDMA postpaid customers.

ii) Any future revision in any GSM based postpaid tariff plan including Add-on plan will also be applicable to CDMA postpaid customers availing the GSM postpaid tariff.

3. This may be brought to the notice of all concerned for taking necessary action in this regard. Proper advertisement as deemed fit may be made to generate adequate response.
