MRP (Incl. of S. Tax) of Top-up voucher	Usage Value
a) Rs.100 to Rs.499	Full usage value equal to MRP
b) Rs.500 to Rs.1999	10% extra usage value on MRP
c) Rs.2000 and above	20% extra usage value on MRP

(ii) Wherever the usage value offered with top-up voucher is more than the usage value offered the higher usage value already offered will prevail.
