



Circular R&C-CFA No.137/17-18

Sub: Promotional scheme for Haryana Circle -reg.

In view of decision of Management committee of Board for closure of CDMA service in Haryana Circle, it has been decided by the Competent Authority to offer following promotional scheme to affected CDMA customers of Haryana Circle for promotional period of 90 days to migrate the CDMA customers into GSM service:-

1) For 1x data customers :

- (i) USB type 3G data card shall be offered free of cost with free activation with GSM 3G SIM card to those 1x customers who will surrender his 1x data card in BSNL CSCs (Applicable for both prepaid & postpaid customers).
- (ii) Prepaid/Postpaid 1X data Customers may choose any existing BSNL GSM data plan in Prepaid/Postpaid data plan respectively.
- (iii) If customers want to retain their existing 10 digit CDMA Mobile Number then such affected customers shall be migrated through **MNP**.
- (iv) All existing terms and conditions for activation of data plan will be applicable.
- (v) Haryana Circle should ensure that all dues have been cleared before allowing migration.

2) For CDMA Voice Retail customers :

- (i) GSM activated SIM shall be offer free of cost to those CDMA active voice Retail customers who will surrender their FWT/IFWT/RUIM in working condition in BSNL CSCs (Applicable for both prepaid & postpaid customers).
- (ii) Customers may have an option to choose any plan under GSM services.
- (iii) If customers are using 10 digits CDMA Mobile Number and want to retain their existing Numbers then such affected customers shall be migrated through MNP.
- (iv) Existing security deposit of CDMA postpaid voice customers shall be transferred as security deposit of New GSM Account. However balance of security deposit (Security deposit as per GSM plan opted by customer – Security deposit transferred from CDMA Customers account), if any, may be taken from customers before migrating the customers.
- (v) All dues should be cleared before allowing the migration.

3) These instructions shall be applicable with immediate effect on promotional basis for a period of 90 days in Haryana Telecom Circle only.

- 4) Haryana Circle should ensure that all customers should be migrated into GSM Technology.
- 5) This may be brought to the notice of all concerned for taking necessary action in this regard.
- 6) Circles have to update their website and report the same to TRAI as per tariff reporting requirement of TRAI.
- 7) The Circle shall ensure to comply with all regulatory mechanism **including on line reporting to TRAI and also update the Circle website.**
- 8) The Circular is issued based on the approval of Competent Authority in NWP-CDMA Cell File No.69-05/2011- CDMA/Vol./pt.
