**Circular R&C No. 37 /09-10**

**Sub – Tariff of Data service for NIC Card and EVDO Card – Revision reg.**

The Tariff for Data Services on CDMA 2000 1X by using BSNL's Network Interface Card (NIC) and EVDO Card has been issued vide no. 115-11/2005-Comml dated 23-05-07, 06-02-08, 25-07-08, 25-11-08, 10-02-09. The said tariff has been extended upto 30.06.09 vide R&C Circular no. 12/09-10 dated 21-04-09.

2. The competent authority has now decided to provide roaming facility on these cards and has, therefore, revised the charges of unlimited internet usage through NIC and EVDO Cards as under :



2. The above tariff will be effective from **1<sup>st</sup> July, 2009** for all new customers. For existing customers who have already taken the cards and are presently getting unlimited service @Rs.250 for NIC and Rs.550 for EVDO card, they have to migrate to higher plan after completion of 6 months period and due intimation has to be given to them as per TRAI directions on the subject.

3. All other terms and conditions will remain the same.
