Sub: Clarification for 'Student Special Plan' offered under prepaid mobile services-reg.

Kindly refer to this office letter of even no. dated 16.06.2016, 24.06.2016, 26-07/2011-T&C-CM dated 12.07.2016, 26-18/2009-T&C-CM dated and letter of even no. dated 31.08.2016 and subsequent orders issued from time to time with regard to 'Student Special Plan' referred above. Based on TRAI observations, the competent authority has decided to clarify that the existing subscribers are allowed to migrate to the "Student Special" Plan, however migration is allowed without free data usage (S. No. (c) of the above referred circular dated 16.06.2016) and Special benefit (S. No. (e) of the above referred circular dated 16.06.2016).

2. All the other terms and conditions will remain same.
3. The implementation of the tariff is to be made in accordance with 43rd Amendment of Telecom Tariff Order and orders/guidelines/clarifications issued by TRAI from time to time.
4. This may be brought to the notice of all concerned for taking necessary action in this regard. Press note and proper advertisement as deemed fit may be made. Circles may also send SMS conveying the above tariff to the customers.
5. Circles have to update their website and report the same to TRAI as per tariff reporting requirement of TRAI. **This is further reiterated that all circles are required to follow TRAI Reporting requirements and unique numbering scheme in accordance with TRAI guidelines, which has been conveyed by Regulation Branch vide letter no. 310-1(1)/2016-F&EA dated 18.07.2016. TRAI has specifically observed that Chennai, Punjab, Kerala, Karnataka, Rajasthan, Maharashtra and Andhra Pradesh Circles have not assigned any unique id to the 'Student Special Plan' referred above. Thus these circles are requested to assign proper unique id to the 'Student Special' plan and report the same to TRAI as per the TRAI guidelines. This shall be treated as Most Urgent.**
