Circular R&C-CFA No. 169/15-16

Sub: Promotional scheme for Punjab, Bihar, Jharkhand, Uttarakhand Telecom Circles & Kolkata TD -reg.

In view of decision to close the CDMA services (Voice +Data) in PB, BH, JKD, UKD Telecom Circles & Kolkata TD by 31-03-2016, it has been decided by the Competent Authority to offer the promotional offer issued vide circular R&C-CFA No. 141/15-16 dated 13-01-2016 to Punjab, Bihar, Jharkhand, Uttarakhand Telecom Circles & Kolkata TD for promotional period of 90 days to migrate the CDMA Customers of Punjab, Bihar, Jharkhand, Uttarakhand Telecom Circles & Kolkata TD into GSM service. The details of tariff plans to be offered are reiterated as below:

1) For EVDO/1x data customers :

- (i) USB type 3G data card (3.6 Mbps) shall be offer free of cost with free activation to those EVDO/1x customers who will surrender his EVDO/1x data card in BSNL CSCs (Applicable for both prepaid & postpaid customers).
- (ii) BSNL will offer promotional postpaid data plan to EVDO/1X data customers with fixed monthly charges of Rs. 750 (10 GB free data) valid for six month. After initial period of six month, customers will be given option to migrate to any existing 3G data plan.
- (iii) Prepaid EVDO/1x data Customers may choose any existing GSM data STVs/plans.
- (iv) If customers want to retain their existing 10 digit CDMA Mobile Number then such affected customers shall be migrated through MNP.
- (v) All existing terms and conditions for activation of data plan will be applicable.
- (vi) Punjab, Bihar, Jharkhand, Uttarakhand Telecom Circles & Kolkata TD should ensure that all dues have been cleared before allowing migration.

2) For Voice customers :

- (i) GSM FWP with activated SIM shall be offer free of cost to those CDMA active voice customers who will surrender his FWT/IFWT in working condition in BSNL CSCs (Applicable for both prepaid & postpaid customers).
- (ii) Customers may have an option to choose any plan under GSM services.
- (iii) No freebies will be offer to these customers at the time of activation of connection of GSM FWP.
- (iv) If customers are using 10 digits CDMA Mobile Number and want to retain their existing Numbers then such affected customers shall be migrated through MNP.
- (v) Existing security deposit of CDMA postpaid voice customers shall be transferred as security deposit of New GSM Account. However balance of security deposit (Security deposit as per GSM plan – Security deposit transferred from CDMA Customers account), if any, may be taken from customers before migrating the customers.
- (vi) All dues should be cleared before allowing the migration.

3. The above tariff will be offered for a promotional period of **90 days** from the date of issue of this letter.

4. This may be brought to the notice of all concerned for taking necessary action in this regard.

5. Punjab, Bihar, Jharkhand, Uttarakhand Telecom Circles & Kolkata TD has to update their website and report the same to TRAI as per tariff reporting requirement of TRAI.

6. Circles shall ensure to comply with all regulatory mechanism.

7. The Circular is issued based on the approval of Competent Authority in NWP- CDMA Cell File No. No.69-05/2011-CDMA/pt-I.
