

2. Existing subscribers of the withdrawn plans shall be allowed to continue in their respective plan till its existing validity. However, they shall be suitably informed about the withdrawal of the plan and options available for migration at the time of validity extension.
3. All other terms and conditions will remain same.
4. The above tariff will be implemented with effect from **01.08.2014**. The implementation of the revised tariff is to be made in accordance with 43rd Amendment of Telecom Tariff Order issued by TRAI. Customers may be informed about withdrawal of plan and suitably educated about the revision in tariff.
5. This may be brought to the notice of all concerned for taking necessary action in this regard. Press note and proper advertisement as deemed fit may be made to generate adequate response.
6. Circles have to update their website and report the same to TRAI as per tariff reporting requirement of TRAI.
7. **Circles are requested to refer to P&P-CM Branch letter no. 3-57/2014-P&P-CM dated 27.06.2014. Proposal for Circle's specific tariff plan with corresponding competitors' tariff plan may be sent to the ECT within time.**
