Sub: Remote Area Tariff plans for Global Satellite Phone service (GSPS)

A new tariff plan named as Remote Area Plan (RAP) has been approved by the competent authority. This plan has two variant i.e. Prepaid Monthly Plan (RAP-1) and Prepaid Annual Plan (RAP-2).

Under Remote Area Plan, the services are to be offered to Governmental or Government appointed representatives in remote area. The registration charges have been waived off under these plans. The detailed tariff plan is enclosed at **Annexure 'A'**. This plan may be offered initially for replacement of DSPT services of Government Agencies. Other cases may be referred to this office for approval.

The ISD Facility, Roaming Facility and call to other Inmarsat services and other Mobile Satellite Phones will be not be provided to customers under this plan.</p> <p>4. At present, WPC Charges are Rs. 14250/- per handset per year which includes Spectrum Charges Rs. 14000/- and License fee Rs. 250/-. WPC charges are to be paid in advance on annual basis. These charges will be deposited by the user to BSNL and BSNL will deposit the same to WPC.</p> <p>5. WPC Charges for 2 years Rs. 28500/- are to be charged in advance for replacement of DSPTs.</p> <p>6. The tariff may be reviewed by BSNL from time to time.</p> <p>7. The Prepaid Plans RAP 1 and RAP 2 are only for replacement of DSPTs.</p> <p>8. The Prepaid Plans RAP 1 and RAP 2 may be offered to other Govt. agency subject to approval of competent authority and on case to case basis.</p> <p>10. Existing customers will not be migrated to these plan.</p>
