Circular T&C-CM No. 100/12-13


Sub: Revision of tariff of STV and Combo Voucher under 2G & 3G prepaid mobile services-reg.

Kindly refer to this office order of even No. dated 11.12.2012 vide which tariff for combo vouchers was issued and order No.26-3/2012-T&C-CM dated 12.06.2012 vide which STV with feature of 1p/2 sec was issued under 2G & 3G prepaid mobile services and orders issued from time to time on the subject mentioned above. Now it has been decided by the Competent Authority to revise the tariff of Combo Voucher and STV as under:-

- i) The free usage of 10 Min Local On-net offered with all feature combo voucher MRP Rs.22 to be revised to 10 Min Local Any Net.
- ii) The MRP of STV with feature of 1p/2 Sec Local Any-Net to be revised from existing Rs.33 to Rs.44 (Incl. of S. Tax). Circles can suitably adjust the MRP in the price band upto Rs.5 (+/-) of above price considering the local market condition and technical feasibility.
- iii) All other terms and conditions will remain same.
- iv) The above tariff will be implemented with effect from **10.01.2013**.

2. This may be brought to the notice of all concerned for taking necessary action in this regard. Press note and proper advertisement as deemed fit may be made to generate adequate response. Circles may also send SMS conveying the above revision in price of STV to the customers.

3. This circular is issued based on the approval of approval of the Competent Authority in P&P-CM cell File No.3-2/2012/P&P-CM (Part). 
